- Note:
- ❖ Candidate should report by 10:00 am on the day of counseling.
  - ❖ If any of the candidates failed to report on the day for counseling his/her candidature will be stand cancelled.
  - ❖ The admission will be made strictly on basis of merit to be prepared on the basis of qualifying examination and CET Rank of Entrance Exam.
  - ❖ Candidates who have been called for counseling are required to bring with them a Cheque / DD of Rs. 40,000/- in favor of Sri Ram Institute of Teacher Education.
  - ❖ Fee has to be deposited by the selected candidates on the day of counseling itself. Candidates, who fails to fulfill the eligibility requirement or do not deposit the fee on the day of counseling will lose their claim for the admission.
  - ❖ At the time of counseling for the B.Ed. Course the candidates required to bring the following certificates/documents in original and set of photocopy (self attested) of each documents as mentioned below:
    - ✓ CET Admit Card
    - ✓ Secondary School Examination (10<sup>th</sup>) (Certificate) for Date of Birth Proof
    - ✓ Mark sheet and Certificate of Senior Secondary School Examination (10+2)
    - ✓ Final Year Mark sheet of UG/PG for proof of minimum eligibility.
    - ✓ In case of students who have passed the qualifying examination through distance/open education system of any recognized university the necessary documentary evidence related to location of his/her study center. i.e. study center proof, certificate from the university imparting open/distance education certifying the location of study center.
    - ✓ Character Certificate (Not more than 6 months old)
    - ✓ Physical Fitness Certificate as per appendix 6 of GGSIPU, Delhi
    - ✓ Reserve Category certificate (if any)
    - ✓ Undertaking by student with respect to anti-ragging by parent and guardian as per Appendix 13 and 14 of Part B of Admission Brochure for Academic Session 2020-2021.
