4. All type of charges and fee relating to the transport facility are subject to revision by the management from time to time.

6. All the students travelling in the college/institute bus should carry the bus pass and produce the same at any time if demanded by the authority.
7. The student must report at the stoppage before 10 minutes as per the scheduled time. In case he/she is late, college/institute is not responsible for his absence in the college.
8. While travelling in the college/institute bus, movement on foot-board is strictly prohibited.
9. All the students/parents are expected to be aware of the transport rules of the college/institute and ignorance of the same will not be an excuse for any dispute/claim.
10. If the student willingly/unwillingly, missed/not board the bus by any mean, the College/Institute Management shall not be liable for any loss/miss-happening faced by the student, during the transit time.
11. The student has to make his/her own arrangement for reporting to the University Examination Center or during School Experience Programme (Teaching Practice).
